

# The Ivers Good Neighbour Scheme

### 106. Minutes

## 107. Matters Arising from the previous meeting

### Reaching out into the community

- (a) Mike had messaged both the Iver and Iver Heath Community Groups on Facebook following completion of the 50<sup>th</sup> client journey. Our own website needs updating to reflect our expansion of the scheme to cover hospital visits, and other option discussed later on at the meeting, (see minutes below), while the contact details need changing by removing Mike's mobile number and replacing this with the generic telephone number 01753 358101. Our website should also make reference to our participation in the Chiltern and South Bucks Lottery. **ACTION: Graham**
- (b) Graham's talk to the WI on 13 November was well received although no new volunteers came forward for registration at the meeting. Mike will be talking to the Iver Mobility Club on the 27<sup>th</sup> November while the talk to Langley & Iver Rotary Club is still to be arranged. Chris is willing to speak to this group.

- (d) Chris was able to organise distribution of the new poster Good Neighbours Wants YOU! on the parish notice boards.
